

Terms of Use of the FON Website

We are FON WIRELESS LIMITED (hereinafter, “FON”), a company registered in the UK with company number 5661131 located at 8, Clifford Street, London W1S, 2LQ that gives access to this Website to the Internet user through the Internet domain www.fon.com and other related domains (hereinafter “Website”).

The use of FON’s website is subject to these Conditions. Remember that use of FON services is subject to the Terms and Conditions of Use of FON services, FON’s Privacy and Data Protection Policies, and the User License of the FON Software. The User should carefully read these and these General Conditions for Use of FON Website each time he/she wishes to access the information located on FON’s website. The contents herein are subject to change from time to time.

1. Use of Cookies and the Activity Log

FON, or a third party contracted by FON, may use “cookies”, small files that are put in the computer of the User, that allow our systems to manage the service and to make visiting-frequency measurements of the site. These “cookies” are not intrusive, nor harmful, nor contain data of a personal nature, given that their only function is to personalize the navigation in the previously expressed manner.

The User may configure his/her browser to be notified each time he/she receives a cookie and to prevent the cookies from being stored within his/her hard drive. Please consult the instruction manuals of your browser for more detailed information.

Furthermore, the FON web servers detect automatically the User’s IP address and domain name. This information is registered in an activity log that allows for processing data which is used for generating statistics about the webpage’s traffic and frequency of use.

2. Access

2.1 Access to this website is open and free of charge. Nevertheless, some of the services and content that FON or third parties offer on this website may be subject to prior agreement as may be stated in the Terms and Conditions of Use of FON services.

2.2 Whenever the User is required to register or provide personal data for accessing a specific service, the collection, treatment, or access to such personal data will be subject to FON’s Privacy and Data Protection Policies.

2.3 Any User who wishes to avail his/herself of one of FON’s products or services through this website must be of legal age and capacity. If the User is not of legal age or does not have the legal capacity to enter into such agreements, the User must first receive the consent of his/her parents,

guardians, or legal representative who shall be considered liable for the actions of the User, in accordance with applicable law.

3. Use of the Web Pages

3.1. The contents of this website are strictly for consumers or finally Users. Any unauthorized commercial use or resale of the contents is prohibited, except with the prior, written and express authorization of FON.

3.2. If the User so chooses to register with FON for the purpose of availing him/herself of one of the FON services, he/she is responsible for providing truthful and accurate information. The User shall have no right to indemnification for such. After such termination, the aforementioned prohibitions on the use of the contents shall continue in effect as expressly stated above.

7. General Provisions

7.1. Headings contained herein are provided for convenience and reference only. Headings in no way affect or limit the interpretation, contents, or terms of these Terms of Use of the FON Website.

7.2. If there is any discrepancy between the terms of these Terms of Use of the FON Website and the Terms and Conditions of FON services, the latter shall prevail.

7.3. Any provision of these conditions which is held invalid or unenforceable in a given jurisdiction shall be ineffective to the extent of such invalidity or unenforceability without invalidating or rendering unenforceable the remaining provisions hereto, and any such invalidity or unenforceability in a given jurisdiction shall not invalidate or render unenforceable such provisions in any other jurisdiction.
